The [Health Care and Social Assistance industry](#)¹ in Alberta includes establishments and services such as:

- hospitals, nursing and residential care facilities and out-patient care centres;
- offices of health practitioners (i.e. dentists, doctors, optometrists and chiropractors);
- medical and diagnostic laboratories;
- home health care services;
- ambulance services;
- social assistance services (i.e. for children, youth, the elderly, families);
- community food, housing, emergency and relief services;
- vocational rehabilitation services; and
- daycare services.

2. Industry's Growth

- The Health Care and Social Assistance industry accounted for 11.4% of total employment in Alberta in 2015.
- Employment in this industry is expected to grow at an average rate of 3.0% from 2015 to 2019⁴.
- The industry is expected to account for 11.1% of total employment in Alberta in 2016.

3. Facts, Trends and Outlook

According to Statistics Canada’s National Economic Accounts, the Health Care and Social Assistance industry accounted for approximately 4.9% of Alberta’s Gross Domestic Product in 2015, up from 4.4% in 2005. Its contribution to Alberta’s total employment increased from 9.6% in 2005 to 11.5% in 2015.

Total employment (the total number of employees and self-employed people, 15 years and over) in 2015 was 9.8% higher than its level in 2014. Over the last 10 years, employment increased by 89,700 from 2005, a 54.1 % increase. There were 264,100 employed in the industry in 2015, of whom 74.0% were full time and 26.0% were part time.

This calculation method also applies to the percentage of employees under union coverage and the percentage of employees working overtime per week.

As a result, the total number of employees by establishment size will not be the same as total employment in the industry, except by coincidence.

2. Demographics: Gender and Age

According to the Labour Force Survey, the gender breakdown in the Health Care and Social Assistance industry in 2015 was as follows:

- women employed: 220,000 people, or 83.3%
- men employed: 44,100 people, or 16.7%

Overall in Alberta, women accounted for 45.1% and men made up 54.9% of total employment (for all industries).

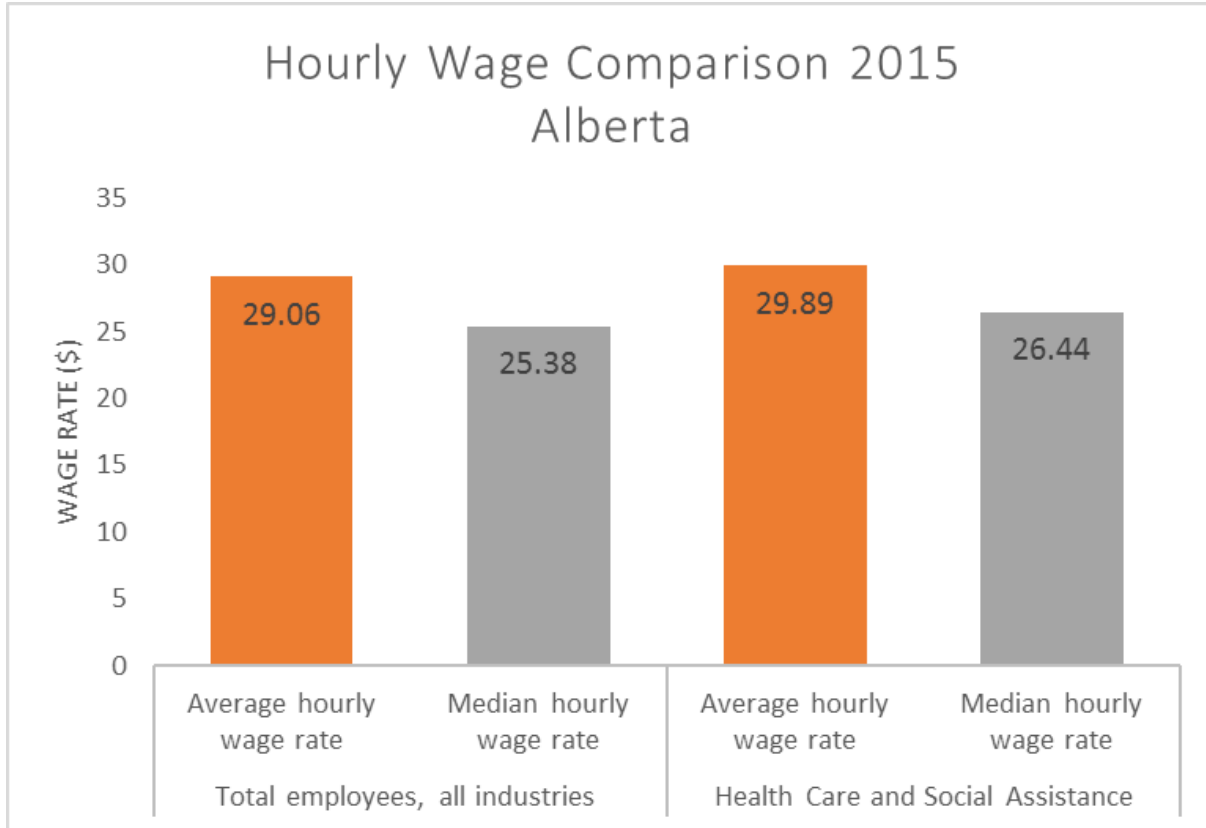
